- **Leave Hip Number** on all horses and leave horses in original stalls.
- **Registration papers** will be withheld for 21 banking days from the date of sale. Cash purchases will receive registration papers the day of sale.
- **Announcements:** Pay attention to all announcements made from the Sale Office and the Auction Block, especially concerning horses on which you intend to bid and/or buy. Announcements take precedence over printed material.
- **Acknowledgement of Purchase:** After making the final bid on a horse, the buyer will be asked to sign the Acknowledgement of Purchase. Be sure to confirm the correct hip number and price before signing. Please print your name and address clearly since this document is used for the AQHA, APHA & NRHA transfers, invoicing, and in publishing sale results.
- **Settlement:** All transactions must be settled during or immediately following the end of each Sale Session. Refer to the Sale Catalog for settlement options, charges and tax information.
- **Buyer's Premium:** 5%. Buyer's Premium will be ENTIRELY DISCOUNTED for purchases paid for by cash, cashier's check, traveler's check or personal check.
- **Check papers** to horse to make sure they match before leaving the sale grounds.
- **Engagements:** Unless announced otherwise, all eligibility payments due after date of sale are the responsibility of the buyer, who should promptly notify the proper associations of the new ownership in order to receive direct billing and information.
